Hi Brian,

I wanted to write to you to let you know of my experience.

Qualified Barrister, 17 years practising in Northern Ireland and never went to Law School in USA, do not have a JD and sat the Bar Exam in Texas in February 2014. Got the previous year's Barbri materials on January 11th and started studying last week of January. Sat the Bar exam and scored 660. Disappointed to say the least.

Thoughts

Barbri - 4/5ths of the material not needed - too much detail - I concentrated on using 2 textbooks to learn the necessary law I needed for the exam.

Civil & Criminal procedure - I did past paper questions off the Texas Board of Law Examiners' website and prepared a summary of the issues that came up on a Word Document and learnt it off. Same issues more or less come up each year.

MBE - You've got to remember that I did go to USA law school and therefore was cramming as much as possible in as short a space as possible. Used BarMax but only got through 600 of the 1600 questions.

Score 660 - last afternoon of the essay questions (Day 3) I did fantastic - top 20 percentile or thereabouts in 5 out of the 6 questions. Felt I had passed when I came out and even celebrated with a beer.

2nd time around I sat Bar Exam in July 2014 - scored 667!!!! Same as above but didn't have the necessary time to properly prep due to work commitments.

Anyways the point is I sat it for the 3rd & final time, February 2015 and passed with a score of 680. I was actually disappointed with my score (can you believe it).

SUMMARY

Barbri - no change as to how I prepared but I did all previous exam questions from the Texas Board of Law Examiners' website and also lots of past paper questions from BarBri Book. I really didn't read too much of the law because I had my notes from previous exams prep and thus 90% of my time was spent doing past paper questions. Again 4/5ths of the Barbri material is not needed and nor do you need the most current up to date books. For 2015 I was using the 2013 editions.

Essay questions - The IRAC concept of answering questions is ridiculous - that is not how real qualified lawyers, short on time etc. deal with problems. IRAC is so artificial and despite trying I eventually give up and could not answer questions in that format at all.

Civil & Criminal procedure - past paper questions over and over again and at the end of it, I had for both topics a 20 page summary each of all the issues I needed to get a good mark.
